Accreditation Assessment Team Invites Public Comment

NORTH BERGEN, HUDSON COUNTY, NJ

A team of assessors from the New Jersey State Association of Chiefs of Police (NJSACOP) on August 4, 2025 will examine all aspects of the North Bergen Police Department policies and procedures, management, operations, and support services Chief Robert J. Farley Jr. announced today.

“Verification by the team that the North Bergen Police Department meets the Commission’s “best practice” standards is part of a voluntary process to achieve accreditation, a highly prized recognition of law enforcement professional excellence,” Chief Robert J. Farley Jr. said.

As part of this final on-site assessment, employees and members of the general public are invited to provide comments to the assessment team. They may do so by telephone or email. The public may call (201) 392-2134 on Monday August 4, 2025, between the hours of 10:00 a.m. and 11:00 a.m. Email comments can be sent to accreditation@northbergenpd.com.

Telephone comments are limited to 5 minutes and must address the agency’s ability to comply with the NJSACOP standards. Please contact the Chief’s Office Lieutenant Anthony Caramucci at (201) 392-2134 for information about the standards.

The North Bergen Police Department must comply with NJSACOP LEAP standards in order to achieve accredited status. Chief Robert J. Farley Jr. indicated, “Accreditation results in greater accountability within the agency, reduced risk and liability exposure, stronger defense against civil lawsuits, increased community advocacy, and more confidence in the agency’s ability to operate efficiently and respond to community needs.”

The Accreditation Program Director for the New Jersey State Association of Chiefs of Police is Mr. Harry J Delgado, Ed.S. “The assessment team is composed of law enforcement practitioners from similar New Jersey law enforcement agencies. The assessors will review written materials, interview agency members, and visit offices and other places where compliance with the standards can be observed. Once the Commission’s assessors complete their review of the agency, they will report to the full Commission, which will then decide if the agency is to be granted accredited status”, Harry J Delgado stated.

Accreditation Assessment Team Invites Public Comment **NORTH BERGEN, HUDSON COUNTY, NJ**

Accreditation is valid for a three-year period during which time the agency must submit annual reports attesting to their continued compliance with those standards under which it was initially accredited.
