Social Media Terms of Use

The North Bergen Police Department (NBPD) provides timely and relevant information to the public through various social media platforms. These platforms are intended to enhance communication, share public safety information, and strengthen community engagement. NBPD is committed to treating all individuals with dignity and respect. We expect the same level of respect from all users interacting with our social media pages. By engaging with any NBPD-sponsored social media platform, you agree to the following terms:

A. User Participation and Content Guidelines

We welcome engagement from our community. However, all comments and content must remain relevant to the topic of the post and align with the purpose of NBPD's social media presence.

NBPD social media pages are not intended for reporting crimes, requesting police services, or addressing emergencies.

The following guidelines apply to all user-generated content:

- Users are subject to the Terms of Service of each social media platform.
- Political endorsements or campaign-related content are not permitted.
- Obscene, vulgar, defamatory, threatening, or harassing language is prohibited.
- Content that targets or disparages any individual or group based on race, ethnicity, religion, gender, sexual orientation, age, or disability is strictly prohibited.
- Content promoting or encouraging illegal activity is not permitted.
- Violations of copyright or trademark laws may result in removal of content.
- Unsubstantiated allegations or content that could interfere with investigations may be removed.
- Commercial advertising or solicitation is prohibited.
- Repetitive, irrelevant, or unintelligible comments may be removed.
- Posts containing personal identifying information may be removed.
- Links to external content that violate these guidelines are prohibited.

NBPD reserves the right to remove content, restrict, or block users who violate these guidelines. The NBPD may also report violations to the hosting platform.

Comments posted by users do not reflect the views of the North Bergen Police Department.

B. Privacy

Users participate at their own risk and are responsible for the information they share. For your safety and privacy, please do not post personal information such as phone numbers, addresses, or dates of birth.

C. Emergencies and Reporting

NBPD social media accounts are not monitored 24 hours a day and are not intended for emergency communication.
